**2. Minutes of previous meetings:** Moved minutes true and correct G. Henry, second W. Rand.

# 3. Business arising from minutes of previous meeting:

- (a) Child Safety all volunteers will require a Working with Vulnerable People registration
- (b) Change Management Ifarm
- (c) 2018 Quilty information released post 2017 SA Quilty ongoing
- (d) Health Check Declaration commences 1 July 2017. Ride Committee enforcing correct paperwork or riders will be turned away. Focus on temperature logs. SMC to provide a policy and procedure to ride committees and members.
- (e) Tasmanian Quilty Team TQ17, Saddlecloths were provided to all team members.
- **(f)** Rule book training ongoing. Amendment to previous minutes 'Aeraspace' to be replaced by the word 'rulebook' in regard to Chief Steward course
- (g) New ride bibs, 50 to be made for 40km riders \$30 per bib. High Visibility vests required.

Their requirement is every rider must wear 'Australian Standards High Visibility' clothing; Orange or green. High Visibility clothing is required by all riders, riding on a state road. SMC to research Australian Standards.
