## 7. AERA

Teleconference held on 19 October 2017 between AERA delegates to discuss motions and proposed amendments. The following items were discussed:

- (a) Overseas horses need to adhere to AERA affiliated ride, use vet cards, may only enter 2 affiliated rides without a logbook.
- (b) Queensland treatment vets, confirm their position on treating all horses. Nearest equine hospitals who will treat horses and their protocols.
- (c) Helmets, Rule 38.1 (c) to be amended.
- (d) Rule 57.4 to be amended.
- (e) Rule 22.3 to include, when dealing with children a responsible adult (appointed by parent or guardian to provide support at an event) is present.

- (f) Rule 26.3 Every rider is responsible for the behaviour of people, dogs, children etc in their camp.
- (g) Rule 27.2 moved to amend clause 9 (b) not required.
- (h) Rider in a youth or lightweight division will not receive national kilometres for FEI events.
- (i) Discussion about new Quilty and State buckles.
- (j) Leg lengths rule 5.16 to be amended.
- (k) Motion NSW private property use, ride organisers will not refuse any entry unless legal orders are against the person.
- (I) Quilty ride base, 1 site per horse.

#### 6. General Business:

- (a) The new BIBS were successfully used at the recent Oss Foley ride.
- (b) Positive swab for NSW horse.
- (c) Cheques to be provided for prizes.
- (d) Nomination forms to be included in the newsletter and website. A nomination letter to be designed. Nominations to be posted to Pat Hodgetts by 30 November 2017.
- (e) Dinner information to be provided in the newsletter.
- (f) Rugs to be collected for the dinner and embroidered. Contact to be made with D. Williams around recipients and committee members, Tania Jago and Pat Lamprey to organise the prizes.
- (g) Committee members up for re-election are Tania Jago, Alan Wyllie, Pam Shadbolt, Jo Marshall and Nicole Ford.
- (h) Discussion raised around the proposed Quilty entry and camping fees.
- (i) Temperature logs are required to be collected at the gate of each ride. There appears to be inconsistencies occurring at different rides. Ride organisers need to have someone at the gate to collect, biosecurity temperature logs.
