1. Election of office bearers

2. Ride nominations

A discussion was held about whether or not to implement TEERA Rule 19.1, requiring riders who nominate for rides late, to pay a late entry fee. It was agreed to consider this again later in 2021.

Trish detailed her progress in implementing a new ride nomination platform – ManeHub. SMC agreed there was a need to 'bring members along' with the new system, which might experience some resistance initially.

Trish will finalise the system for first ride. Kaye and Trish to work together on a communication strategy to inform members about the new platform.
