# Minutes GENERAL MEETING Monday 4 April, 2016 6:30 pm Uniting Church, Latrobe

Previous Minutes – as there was a muck up on dates for the meeting – no minutes were available. Meeting went as follows: -

1. Norm – NTARC – no discussions as yet on Grants. Norm expressed concerns regarding NTARC not getting entry details until after the ride had started. Pam explained that sometimes it is just not possible. Also wondered about getting an Ipad or similar to let timekeeper know when horses have gone past the last checkpoint – Pam also informed him that it isn't really a necessity as we go by sight. Discussion on the hay bales used for the riders to enter single file – okay probably on check points, but not at the finish line. Advised that they should stick with the readers they have already. (Norm then left the meeting).

### 2. AERA Meeting Update: -

- b. AERA had a \$39000 profit last year major costs are insurance and buckles. They also asked that we pay our dues monthly and electronically if at all possible.

- e. Tom McCormack is still trying to organise a national entry system.
- f. Discussion on arrows
- g. Gerard & Tom are to come and do a Chief Steward refresher try and sort a time for them to come possibly State Champs Fundraiser Weekend in June?
- h. TEERA are to sponsor a rug in the Vic Quilty \$500.
- i. Letter from Vic Quilty asking for our State Rep Chief Steward & Vet.
- j. SA Quilty -7/7/17.
- k. Coffee Table books extra 100 ordered TEERA to sell ours off.
- I. Vic Quilty are using 50/50 for fundraising look at options.
- m. 10,000km Awards riders need to apply and the State Registrar to check.
- n. Tom & Steve are sorting the Invasive Treatment details.
- o. AERASPACE and Zowetus? Are joining forces to track Hendra Vac horses via microchip.
- Biosecurity strangles is rampant in Vic & SA. Documents have been adopted –
   States expected to adopt as well temp logs etc.
- q. Mandatory Rest Orders didn't happen. Look into Early Warning System instead.

- r. Child Protection make it a rule from now on that no adult is to go out with a child alone to help on track 2 people at all times.
- s. July AERA meeting Wendy & Pat to attend.

#### 3. Chief Steward Reports: -

- a. NEEEC Easter Marathon Mark Dunn.
  - i. If a rider has fallen from a horse and banged their head what does it mean for the helmet should a new one be used at the next ride?
  - ii. Horse Nose Bleeds Pat outlined observations.
  - iii. Member both their horses were misbehaving.
  - iv. Water on track needs to be provided every 5km.
  - v. Noted that stallion was misbehaving in vet ring.
  - vi. Disqualification for horses which don't allow temperature to be taken at TPRing to be put on Website.
  - vii. Disciplinary action member coming next meeting but also need to discuss horse's behaviour at Easter Marathon.
  - viii. What are the procedures if there are disputes amongst members and the Police are called is it still the Chief Stewards call?

Letter to be sent to two members to come and provide a reason for horses' poor performance at the Easter Marathon Letter to be sent to NEEEC to make sure that they provide sufficient water at their next ride – 5km intervals.

- 4. Debbie Grull wrote a 3-page letter on the Marathon ride not a lot really requiring attention.
- 5. The Pickering & Wyllie camps are interested in hosting a TPR course Pat is willing to assist.
