8. General Business:

- a) Newsletter few items to go in eg rider behaviour towards officials.
- b) Lack of information for those starting out can we put a friendly checklist on the ride entry form for 20s and 40s.
- c) Trainer declaration ride secretaries need to be aware that Aeraspace automatically puts the rider's name underneath. Trainer must be a full member and must sign.
- d) **Need biosecurity form on the entry form. Need three day temp log on all horses. Form on the AERA website.
- e) TQ2018 Minutes 23 April and Contact List tabled
- f) Kimberley truck came very close to horses and was speeding. Ride committee had appropriate signage and taken as many precautions as they could. Greg suggested they get hold of some flashing lights or similar. Not really an acceptable alternative route either. Greg will also go and talk to the local police and find out what we can use and do. Discussion about rides on the road.
- g) Rule go to vet ring without bit in horse's mouth unless we have permission from the vet. G Henry asked about the ruling and having to ask at each ride. P Hodgetts said she does not mind at all if it gives the handler more control.
- h) Approval given for state champs fundraiser put on a 20km ride on the Saturday.
- i) Reminder that no heart rate monitors should be used when the TPR is taking the heart rate. Can be taken into the vet ring but not used.
- j) Microchips need to buy some more. Nicole can order for \$14.85 each plus postage. Will order 50.
- k) Need to order vet cards. Nicole to order 250.
- Number of people who had booked in to ride and then cancelled. 26 at last ride who had cancelled. Reminder on the website just courtesy to ride organisers as can run at a loss.
