Some comments from Mark on the missing HHDs from the two 20k late arrivals.

As lan wrote, when we became aware of this the two riders were asked to unload their horses and keep them away from any other horses until we'd had a discussion about what to do.

They pleaded ignorance as to the need to bring the HHDs along. FYI, there was no notice on the STER ride nomination page telling folk this was a mandatory requirement - this has now been put back on the nomination pages for all rides - and this is also not specifically spelled out on the form itself.

I asked Khyle, as head vet, for his suggestion. He suggested he examine the horses and, if no biosecurity threat or horse health issue was identified, the horses be allowed to start. Both Ian and I agreed with this - this was what I was thinking too, largely on the basis that my assessment of the risk of a biosecurity incident in Tasmania at this time is minimal. Not wanting to disappoint / discourage two riders, one young, who had travelled up from Hobart was also a factor.

Proposed action - already done - ensure that the ride nomination pages on the website note that presentation of a HHD is a mandatory requirement for entry to the ride base and decline entry to those who arrive without one.

iii. Wattlewood Park

All noted – no further comments.

10. Sub optimal ID pages in log books

Mark reported that he had noticed at recent rides that a few horses have had log books with ID pages that are missing obvious markings on the horse, presumably because the owner has sent along a poorly completed ID sheet. This has been discussed on the AERA CS Facebook group – consensus was for the ride CS / owner to amend the ID page so that it does match the horse.

Action - head vet and CS to amend page, annotate and sign. Mark to email to CSs to advise.

11. AERA Rule change proposals - attached

Mark noted that, as the AERA MC member from Tasmania, it is his intention to support all Rule change proposals.

SMC supports except for the 'blood' rule proposal. Some SMC believe the change is unnecessary and, also, that it might be 'gamed'. AERA MC member Mark agreed to put this to the AERA MC meeting.

SMC believes that, in future, Rule change proposals need to be circulated to the wider membership – this to be done in future.

Mark commented that, with the change in AERA Constitution, the process for Rule changes is currently uncertain and vague at an AERA level.

He added that all decisions by the AERA MC are now, in theory, made by the MC members independently of their DA SMC. He further added that, regardless, he believed all MC members, including him, are likely to be strongly influenced by the views of their respective DA SMCs.

TEERA to provide or not? From Pat H:

'we used to get them from AERA. Now from local vets. I think the last lot through Debbie Grull. If needed ---perhaps could ask Celine to provide at near cost !!??

Now that things have progresed from the dark ages it is perhaps the responsibility of the owners to arrange from their local/usual vet to supply and insert the microchips.

All horse owners should have access a local vet who inserst microchips. Some breeders/stud owners are known to have a supply of microchips (from ???) and pop them into foals soon after they are born.

I think Teera could walk away from this supply now.

I still have concerns that the horse ID should be done by equine vets that understand the process and terminology BUT if the microchip is correct then the ID does not really matter unless there is no microchip reader avail.'

Action: TEERA no longer to provide chips. Mark to post note to website and FB

19. High vis bibs

40/80k bibs - Andrew

Email from Debbie Grull 25/5/21 (Mark – acknowledges and told we'd discuss at this meeting).

Hello TEERA,

A few years back we replaced the 40 km ride bibs with high vis yellow.

The driver for this was state roads, who may be consulted by some ride committees for an event/endraunce ride permit (where the ride incorporates some state roads in the event). I recall it being somewhat interesting to negotiate the proposal to update 40 km ride bibs to new high vis bibs, with the TEERA SMC, with a final decision that high vis bibs were essentially a no brainer.

I wonder what high vis bibs we have for the 20 km riders, or 5 km riders, or stallion riders? Can TEERA please table this as a topic for discussion please.

At present, (I think) TEERA uses

high vis Orange (black print number) for 80 km riders

high vis Yellow (black print number) for 40 km riders

high vis Yellow (white print number) for 160 km riders

yellow or old green bibs not high vis for 20 km riders

re bibs <u>not high vis f</u>or 5 km riders

stallions (blue bibs with a letter) not high vis

Discussion – SMC believes all bibs are currently in use are fit for purpose

Action – 20k bibs, stallion bibs to be replaced when the budget allows. Trent to research Aus standard (if there is one). Mark to reply to Debbie noting SMC consideration of matter and actions.

Andrew and Amelia to progress the offer to members to replace their old or worn 80k bibs.

20. Early Warning System (EWS)

Trish to report directly to Pink ride CS on any relevant matters

21. State Champs

Call for expressions of interest has gone out – deadline was 31 May. One EOI received – MEER. SMC accepts nomination and congratulates MEER on stepping up.
